On the whole, the **Journal of the National Society of Allotment & Leisure Gardeners** makes good bedtime reading - it puts *me* to sleep, anyway - but one article in the current edition made me sit up & take notice. It concerns a battle over allotment plots in Eastleigh, Hampshire, where the local council has decided to get rid of 3 sites, to make way for more housing. There's no planning permission to build, or ministerial consent for the disposal of the sites, yet plot holders are being encouraged to move off, & no new lettings are being allowed. Alternative sites are offered, but they're miles away, next to a motorway and permanently waterlogged. The fact that this can be done by a council worries me, because I see the possibility that a cash-strapped local council could always try to do the same with *our* plots too. Not that we need to contemplate a campaign of civil disobedience just yet, but it does show how important it is to show the council that we really value - & need- our plots. And there's no better way of doing that than by keeping them tidy & tilled all through the year, & not just when the weather's balmy. So I guess I'd better stop wittering on, and go & do *my* bit to make sure our council won't consider re-classifying our site...
